Ancillary RGN Benefits: Superior Case Study

- 6 departments met in person in Nov. for 2-hour brainstorming

- Developing and leveraging inter-jurisdictional partnerships (CAMP, fire recovery)
- Qualitative and quantitative benefits beyond RGN, IRA and IIJA due to silo busting

 Charge Ahead Colorado, Fleet Zero, GOCO



Year 3 Workplan

- Disseminate information on new federal criteria and programmatic changes
- Assist with shifting strategies to align on most competitive applications
- Analyze who has not yet participated in RGN program
- Reach out to communities that haven't engaged with RGN to date
- Provide extra capacity to help communities navigate transformation of programs and scoring criteria





Resources from our Partners at Peak

WSB coordinated with Peak Consulting to develop a Project Prioritization **Screening Tool** to identify their most grant-ready projects. Several municipalities, such as Arvada and Brighton, have utilized this to efficiently focus grant research on highest priorities.

A **Grant Readiness Checklist** has also been developed to educate Municipal leaders on eligibility requirements, which streamlines the application process and improves the chances of winning the grant.

WSB and Peak plan to further our **engagement** with communities to discuss strategies for grant readiness, align with administrative priorities, listen to feedback, and provide insight and tools to find funds.
