Project Description:

This project involves the replacement of the culverts under N. Pecos Street along Tributary M of Niver Creek. The project is needed to improve the drainage and lessen the risk of the road overtopping and decrease the backwater condition, which causes the flooding of homes to the west of N. Pecos Street. N. Pecos Street will be milled and overlaid following the culvert replacement.

Project Name: Littleton Connects: Active Mobility Network for All Project

Project Type: Planning

Project Description:

The City of Littleton (City) requests \$2.56 million in BUILD Planning Grant funding to conduct the \$3.2 million Littleton Connects: Active Mobility Network for All Project (Project) to advance the evaluation, planning, and design of safety-related infrastructure improvements along ten critical connector corridors throughout the City of Littleton. These critical corridors were prioritized for this planning study based on their existing connections to the City's active transportation network and providing connectivity to schools, job centers, transit services, retail and commercial hubs, parks and other key destinations. BUILD funding will advance near term implementation of safety improvements in high crash areas and improve multimodal connectivity throughout Littleton by facilitating the City's efforts to collect and analyze data, prioritize locations for investments, and develop designs for specific projects. This work will ultimately result in a safer infrastructure system, one that fosters accessible multimodal transportation options for people of all ages and abilities.
